The role demands up-to-date and in-depth knowledge of the advanced accounting and financial techniques and very good in IT/SAP skills. He will collaborate closely and report to the Managing Director in driving transformational changes in WBSETCL.

Qualification: Chartered Accountant/ Cost Accountant/ MBA (Finance)

Experience: The candidates should have at least 20 years of relevant experience with 10 years at senior management level in Finance and Accounts functions in a large engineering concern/ power utility/ manufacturing concern, CPSEs, PSU or similar reputed private sector organization in the power sector with at least 2 years in the capacity of Executive Director (Finance)/ Controller of Finance/ General Manager (Finance)/ Chief Financial Officer or equivalent post.

Age: Maximum 61 years as on 01.01.2026

Tenure of Appointment: The position is on contract for an initial duration of 3 years with the conditions of performance review at the end of each year, linked to review of the contract.

Compensation: a) The Post carries the pay in the Pay Band of Rs. 1,56,500/- to Rs. 2,10,800/- plus Dearness Allowance (DA), House Rent Allowance (HRA), Electricity Allowance, Medical Allowance, Leave Travel Concession and free hospitalization benefits at reputed Hospitals and chauffeur driven car at the cost for official work.

b) Consolidated remuneration of the personnel appointed as Director after retirement or cessation of service from any PSUs / CPSEs / Private Sector having no pension shall be Rs. 2.30 lakhs (two Lakh Thirty Thousand only) per month. Such consolidated remuneration shall not contain any allowances like DA, HRA, Public Relation Allowance, Electricity Allowance, Medical Allowance, etc. The consolidated remuneration shall increase by Rs. 6,500/- on 1st July, every year provided at least 6 months of service is performed in the Company. c) The remuneration of the personnel appointed as Director after retirement from pensionable service (excluding EPF Pension) under State Government / Central Government / Parastatal (where superannuation pension exist) shall be on 'Last Pay minus Pension', i.e., Last Basic Pay drawn on the date of retirement together with DA & HRA as admissible minus Pension before commutation together with Dearness Relief on Pension.
